I am directed to inform that in terms of Rule 8 of West Bengal Services (Recruitment to clerical cadre) Rules, 2019 as notified under the Finance Department notification no.662-F(P2), dated 24/01/2019 read with F.D. notification no. 9045-F, dated the 26th July, 1983 the next Half-yearly Departmental Examination in Bengali for probationary L.D. Assistant/Clerks, who took Hindi/Urdu/Nepali or Santali, as the case may be in lieu of Bengali in Group-'B' of Part-II of the competitive examination/whose mother tongue is not Bengali, May, 2024, will be held on the 25th June, 2024 in the Examination Hall of the Commission at 161A, S. P. Mukherjee Road, Kolkata -700026.

The examination is proposed to be held in two parts viz. Part-I (Written) and Part-II (Oral). Candidates who have already been passed in one part shall not be required to appear in the same part again. Details of both the parts of the examination are given in Annexure-I as enclosed.

It may be noted that names received thereafter will not be entertained by the Commission for the examination. The time-table of the examination will be communicated to the candidates through their respective Departments/ Offices in due course.
